

# GARDEN CITY BEER/WINE PERMIT

1. It is understood that those under the age of twenty-one (21) will not be allowed to purchase, consume or possess beer and/or wine. (GCC 3-2B-13B)
2. It is understood that beer/wine will not be sold or vended in any fashion, or be the basis to solicit donations, contributions, or any form of payment unless the solicitor has a Liquor Catering Permit. (Liquor Catering Permit GCC 3-2A-5)
3. It is understood that all state, county and city laws in regard to alcoholic beverages will be obeyed.
4. It is understood that persons attending a function will be subject to obey all federal, state, county and city laws. Failure to do so could result in prosecution.
5. It is understood that those participating in beer/wine functions will remain orderly in accordance with GCC 4-12-4 and will not restrict in any manner, normal vehicle or pedestrian use of roadways, paths, walks and parks.
6. In the event the beer/wine use authorized by this permit results in the violation of any of the permit conditions, or federal, state, county and city laws, the individual representative and group name hereon will not be granted another permit.
7. It is understood that should persons attending the functions be cited for violations of any activity associated with the beer/wine consumption, this permit may be revoked by the responding officer(s), the alcohol be confiscated and/or group be disbanded.
8. It is understood that no glass bottles shall be used at the facility except for those used by a caterer with a Liquor Catering Permit (GCC 3-2A-5).
9. The Applicant shall be responsible for the actions of the participants and is required to be present with this permit during the entire time of the function. Should the Applicant leave the area of the function, the Alternate Representative (below) shall be designated as his/her agent for purposes of this permit.
10. This permit provides a means of police enforcement. The City of Garden City assumes no liability for the negligence of any individual which results from alcohol consumption at this function.
11. Beer/wine consumption is prohibited upon any street, in any public or private parking lot, in or upon any public vehicle commonly used for the transportation of passengers or in or upon a private vehicle located or being driven on any street. (GCC 3-2-3)
